- 1) Weeds and Water Quality
 - A. Jason reported on his conversation with Lake Management with respect to promoting a single source weed treatment service. He confirmed that they must follow DNR guidelines regarding the maximum lake treatment not exceeding

15%. Each homeowner would be responsible for contracting individually as was the case in years back. Jason will ask Lake Management to review their records and determine who participated in years past. The estimate was \$2.42 psf. It was felt that Mike Manthei and Jeff Swan had taken lakeshore measurements and everyone will check their records or follow up with Mike to obtain that information.

 a) Lincoln questioned how the 15% was calculated. Jason will further investigate with Lake Mangement. Tom will follow up with the DNR.

- B. Lincoln report on a chemical named Alom, which is a natural treatment that binds with phosphorus, keeping it from releasing. This results in the reduction of algae and helps clear up the lake. There are many variables with this treatment so the exact outcome is hard to predict. If we clear the lake, will more of the native plants grow? This is needed in order to obtain DNR permission to treat more in the future. However, the Alom does not distinguish which plants, the native or the invasive, would grow.
 - a) The SLIA will make a formal request to the VBWD asking for financial support to engage the services of the Lake Detective. SLIA would need to ask VBWD to be placed on the agenda to make the formal request.
 - b) In the absence of receiving funds from VNWD, Board member Ziemer made the motion to approve funds to hire the Lake Detective to investigate Silver Lake, seconded by board member Luikonen, all ayes, motion carried.
 - c) Lincoln suggested we receive a time frame for the work and also offered to review the scope of the Lake Detectives proposal and provide his input. He felt it should be determined up front what documents he would require so that the SLIA and VBWD could obtain those documents and move the process along.
- C. Lincoln also mentioned a PCA Program that is in place to try and catch impairments and treat prior to a lake becoming impaired. Silver Lake is not considered an impaired lake so this program may be a future option.
- D. Lincoln provided the following link to provide a a better explanation of the MPCA Water Quality Protection and Restoration program, and how it fits into the overall MPCA Watershed Approach for improving MN water quality. This is the program that will be worked for Silver Lake (and other waterbodies in the VBWD) beginning in the fall of 2012.
