- Trying to figure out how to get regular updates regarding the road construction on 120, currently it is not funded.
- Currently there is no filtration from the road it goes right into the lake, what will be in place to protect the lake?
- No updates on MDot website. Anne has been reaching out, but no response
- Anne will share the URL's for upcoming road projects
- Paul Kaari natural products, phosphorus binding treatment, can be put into the lake. These are newer products and in the process of being refined. The purpose would be to target and offset phosphorus due to run-off.
 - Keegan Lund is the product rep for these new projects. His previous job was with the DNR and is very knowledgeable about these products and the needs of the local lakes. He also assisted with our fluridone treatment.
- Comment related to algae: Is the current algae regular spring algae?
 - Paul and Amber speculate it's most likely from the weed kill last year but seems pretty early. Could either be either the decaying plant material released phosphorus into the lake for the algae or the lack of EWM growth left extra phosphorus for the algae. Not 100% sure but an option.
 - Paul may be out on the lake in late April/Early May to calibrate his equipment before shoreline treatments and assess the health of the lake, specifically look at previous EWM hotspots
 - o No products will be distributed just calibrations
 - Keep your eyes open for Purple loosestrife
